Dear Storage Participant:

Please note the following dates have been designated for the 2016/2017 vehicle storage season:

Saturday, October 29, 2016	8:00 a.m. to 12:00 p.m.
Saturday, November 5, 2016	8:00 a.m. to 12:00 p.m.

The entrance to the grounds will be, as in the past, from the Ironwood Road Gate #1. PLEASE REPORT TO THE FAIR OPERATIONS OFFICE BEFORE PARKING YOUR VEHICLE. The storage program is on a first come basis. Please be reminded that there will be a \$25.00 fine for vehicles not removed by the release date. The buildings are equipped with fire and theft protection, but are not heated.

There will be one Saturday for removal, which will be Saturday, March 18, 2017, between the hours of 8:00 a.m. and Noon. If you were one of the last vehicles parked in a particular building, you must be here promptly on March 18 because until you remove your vehicle, no other vehicles will be able to move out.

When you bring your vehicle for storage in October or November, you will be asked to provide the license plate number for the vehicle you are leaving for storage (for identification purposes). Please have this ready when you come to the office. For your convenience, we have enclosed a release form you can complete prior to your arrival. Please bring this completed form to the office upon your arrival; this should help alleviate waiting in a lengthy line at the office. Additional forms can also be found on our web site at [www.4hfair.com](http://www.4hfair.com). **If you are not a member of 4-H Fair, Inc., you will be asked for a \$2.00 membership fee which is good for a 5 year period.**

Fees for the 2016-2017 season are on the enclosed page. NOTE: These rates are determined by the TOTAL LENGTH, including tongue or other projections.

We have discovered in the past that Saturdays are not always good days to schedule storage for some people. Therefore, we tried this on a limited basis last year and since it seemed to work well, we are opening it to everyone this year. **For an additional \$25.00 per vehicle over and above the storage rate, you will be permitted, with an appointment, to bring your vehicle to the Fairgrounds between 1:00 p.m. and 4:00 p.m., Wednesday Thursday or Friday, during the week prior to the scheduled storage Saturday.** If these dates are still not convenient, for an additional fee of \$50 per vehicle you can come in prior to Wednesday, October 26, or Wednesday, November 2. This means, with a phone call to let us know when you are coming, October 26 through October 28, or November 1 through 4, for \$25.00 additional per vehicle, or \$50 any day other than Wednesday, Thursday or Friday, you can avoid having to wait in line on either Saturday.
